Regarding Paper -III of Engineering Drawing Subject (Conventional Pattern) for Semester-II, III & IV those who wish to apply for Re-valuation of their marks should submit their applications through their respective I.T.I.s on or before 31.10.2016 and in turn ITI's should submit the same to the Examination cell by 07.11.2016 positively. Private Candidates who wish to apply for re-valuation of their marks in Paper-III of Engineering Drawing of II, III & IV Semester should also do so by submitting their application forms duly filled to the examination cell, O/o State Directorate of Craftsmen Training, Panaji-Goa by 07/11/2016.
