ALL INDIA TRADE TEST OF CRAFTSMEN,
(CONVENTIONAL PATTERN,JULY/AUGUST,2016)(NCVT)

Results of All India Trade Test of Craftsmen under conventional pattern,July/August,2016 (NCVT) held in the month of July/August,2016 are declared.

All those concerned are hereby informed that the result of All India Trade Test of Craftsmen under conventional pattern, July/August,2016 (NCVT) held in the month of July/August,2016 have been declared by the Board of Examination under CTS Scheme.The results sheets would be displayed on the notice board of respective I.T.I.s.

All the **ex-failed trainees** including **private candidates** who wish to re-appear for the ensuing **All India Trade Test of Craftsmen under conventional pattern,January, 2017(NCVT)** should approach the respective ITIs and the private candidates should approach the examination Cell,O/o State Directorate of Craftsmen Training,Panaji-Goa to fill in their forms in all respects.The Last date to receive such applications in the respective I.T.I.s is **21.11.2016** (i.e., for **ex-failed trainees through their I.T.I.s and private candidates through examination cell**) and the same applications along with the copy of **challan payment receipt**, the statement of Trainees appearing subjectwise as mentioned in "**Annexure A**" should reach the examination cell,O/o State Directorate of Craftsmen Training,Panaji-Goa from respective I.T.I.s positively by **25.11.2016** for candidates applying through I.T.I.s. **No applications shall be entertained, whatsoever after due date.**

It may be noted that All India / All Goa Trade Test of Craftsmen under Conventional pattern(NCVT/SCVT)is conducted every year in the month of January/February and July/ August session.However,the last chance to appear in AITT of Craftsmen(Conventional Pattern) under CTS for 1 year duration was **July/August,2016** which is already over and for 2 years duration course is **July,2017**.Since the Last batch for the Conventional pattern was admitted in Session **August,2013**,it is decided by the Competent authority to discontinue the NIMI question papers under CTS from July/August,2016 and onward **vide letter MSDE-18011/02/2016-TTC dated 13/04/2016 and 19/04/2016**.Now the trainee has to attempt **subjective question papers** in conventional examination and will have to answer on normal answer book in place of NIMI answer book.The same is applicable to Private candidates who are eligible to answer All India Trade Test of Craftsmen under Conventional Pattern,(NCVT).
