All those concerned are hereby informed that the results of All India Trade Test of Craftsmen under Semester System(I,II,III &IV) ,Ex-failed and Regular Trainees(NCVT) held in the month of July, August,2017 (MIS) have been declared on the NCVT MIS PORTAL by the Ministry of Skill Development and Entrepreneurship, New Delhi, also the results of All India Trade Test of craftsmen under semester system(2nd) ex-failed trainees admitted in the year 2013 and ex-failed trainees of 4th semester re-admitted in the year August,2015 (NCVT) Examination held in the month of July/August,2017(NON-MIS) have been declared by the Board of Examination of Directorate of Skill Development & Entrepreneurship, Goa.

The results of AITT (NCVT) under MIS are available on the NCVT MIS PORTAL <https://ncvtmis.gov.in/> and the results of AITT(NCVT) NON-MIS will be available in the respective ITIs, as applicable.

All the Ex-failed trainees & Regular trainees who wish to re-appear/appear for the ensuing AITT of Craftsmen under semester system for (1st,2nd, 3rd & 4th Semester) to be held in the month of January/February,2018 should approach the respective ITIs to fill their forms in all respects. The Last date to receive such applications in the respective ITIs is **05-12-2017** & the same application along with the copy of Challan payment receipt, the statement of trainees appearing subject wise (Ex-failed) mentioned in Annexure-"A" should reach the examination cell, O/o DSDE, Panaji-Goa on **08-12-2017**. The Last date to accept the examination fees by the respective ITIs from the regular trainees is **05-12-2017** and the Copy of Challan payment receipt alongwith Annexure-"B", statement of regular trainees likely to appear tradewise shall reach the examination cell on or before **08-12-2017**. Principal, Private ITIs shall collect the **examination fees** from ex-failed/regular trainees and submit the same alongwith the enclosing letter directly to the examination cell, O/o DSDE, Panaji-Goa for verification purpose and after duly certifying, deposit the cash with the Cashier, Accounts section, O/o DSDE, Panaji-Goa on or before **05-12-2017**. No application shall be entertained whatsoever after due date.

It is also informed that the Principals, Govt/Private of respective ITIs should collect Rs.75/- (Rupees Seventy Five Only) towards **OMR fees** from the Regular and Ex-failed trainees who wish to appear/re-appear for **AITT of Craftsmen under semester system (1,2,3&4) to be held in the month of January/February,2018** & submit the same alongwith the enclosing letter directly to the examination cell, O/o DSDE, Panaji-Goa for verification purpose and after duly certifying, deposit the cash with the Cashier, Accounts section, O/o DSDE, Panaji-Goa on or before **05-12-2017**.
