### ALL INDIA TRADE TEST OF CRAFTSMEN, UNDER SEMESTER SYSTEM, 2<sup>nd</sup> and 3<sup>rd</sup> (Ex-failed) and 4<sup>th</sup> SEMESTER (Regular) EXAMINATION HELD IN, AUGUST, 2015


Results of All India Trade Test of Craftsmen under semester system 2<sup>nd</sup>, 3<sup>rd</sup> (Ex-failed trainees) and 4<sup>th</sup> Semester (Regular trainees) held in the month of August, 2015 are declared.

All those concerned are hereby informed that the result of AITT 2<sup>nd</sup> Semester (Admission Year 2014) is declared on the MIS NCVT portal by MSDE, New Delhi and subsequently, the results of 1<sup>st</sup> Semester (Ex-failed trainees - admission year 2014) will be declared by MIS Shortly as mentioned vide letter No. MSDE-18011/02/Sem. July/2015-TTC(Pt.) dated: 26<sup>th</sup> October, 2015.

Results of 2<sup>nd</sup>, 3<sup>rd</sup> (for Ex-failed trainees) and 4<sup>th</sup> semester (Regular trainees) admitted in the year 2013 of All India Trade Test of Craftsmen under semester system held in the month of August, 2015 have been declared by the Board of examination under CTS Scheme. The results would be available for viewing in the respective I.T.I.s.

All the ex-failed trainees who wish to re-appear for the ensuing All India Trade Test of Craftsmen under semester pattern system (1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Semester) to be held in month of January/February, 2016 should approach the respective ITIs to fill in their forms in all respects. The Last date to receive such applications in the respective I.T.I.s is **16/11/2015** and the same applications along with the copy of **challan payment receipt**, the statement of Trainees appearing subjectwise (ex-failed) and regular trainees as mentioned in "Annexure A" should reach the examination cell, O/o State Directorate of Craftsmen Training, Panaji-Goa from respective I.T.I.s positively by **20/11/2015** for candidates applying through I.T.I.s. **No applications shall be entertained, whatsoever after due date.**

Further, it is also informed that the principals of respective ITIs should collect **Rs. 75/- (Rupees Seventy five Only)** towards charges of OMR Sheets from the regular and ex-failed trainees who wish to appear/re-appear the AITT of Craftsmen under semester system (I, II, III & IV) to be held in the month of **January/February, 2016** and the same should be deposited along with complete Semester/tradewise details to Cashier, Accounts section, O/o SDCT, Panaji-Goa on or before **27/11/2015** and a copy of the same to be forwarded to the ACE, O/o SDCT, Panaji-Goa.
