
All those concerned are hereby informed that the results of All India/All Goa Trade Test of Craftsmen, COE-BBBT (Broad Based Basic Training) & Advanced Modules, NCVT/SCVT, March/April, 2017 have been declared by the Board of Examination under CTS Scheme. The results would be available for viewing in the respective I.T.I.s.

All the ex-failed trainees who wish to re-appear for the ensuing All India/All Goa Trade Test of Craftsmen, COE-BBBT (Broad Based Basic Training) & Advanced Modules NCVT/SCVT, August, 2017 should approach the respective ITIs to fill in their forms in all respects. The Last date to receive such applications in the respective I.T.I.s is **10.07.2017** and the same applications along with the copy of challan payment receipt, the statement of Trainees appearing subjectwise as mentioned in Annexure "A" should reach the examination cell, O/o Directorate of Skill Development & Entrepreneurship, Panaji-Goa from respective I.T.I.s positively by **14.07.2017** for candidates applying through I.T.I.s.

No applications shall be entertained, whatsoever after due date.

The Examination fees from the Regular Trainees shall be collected on or before **10.07.2017** and the same copy of Challan Payment receipt alongwith Annexure "B", statement showing the number of trainees likely to appear for ensuing All India/All Goa Trade Test of Craftsmen, COE-BBBT (Broad Based Basic Training) & Advanced Modules NCVT/SCVT, August, 2017 shall reach the examination cell positively by **14.07.2017**.

It is also informed that those who wish to apply for Revaluation of their marks should submit their application through their respective ITI's on or before **27.06.2017** and application so received should reach Examination Cell from respective ITI's positively by **30.06.2017**.
