Results of All India/All Goa Trade Test of Craftsmen,COE-BBBT(Broad Based Basic Training) & Advanced Modules,NCVT/SCVT and Short Term Course Examination held in the month of **SEPTEMBER, 2018** is declared.

The Examination fees from the Regular Trainees shall be collected on or before **04.12.2018** and the same copy of Challan Payment receipt alongwith Annexure "B", statement showing the number of trainees likely to appear for ensuing All India/All Goa Trade Test of Craftsmen,COE-BBBT(Broad Based Basic Training) & Advanced Modules NCVT/SCVT, **March,2019** shall reach the examination cell positively by **07.12.2018**.
